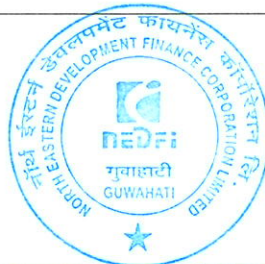
Sub: Limited Tender for Supply, Installation and Commissioning of One Rack Server Through Buy back of two Existing Rack Servers

- b) Only hard copy of the proposal shall be accepted. All pages of the proposal shall be sealed & signed by the authorized signatory of the bidder. Only sealed enveloped proposals shall be accepted.
- c) Bidder should be authorized partner/seller/reseller of the quoted brand and shall be responsible for providing after sale support of the items.
- d) Bidder should have offices in Guwahati. KYC documents of the bidder like PAN and Proof of Address etc. should be submitted along with tender.
- e) Bid Security: The bidder needs to submit an EMD amounting Rs. 15,000/- (rupees fifteen thousand only) as bid security. The EMD of the successful bidder will be forfeited if they cannot complete the work within the timeframe. EMD of un-successful bidder will be returned after the finalization of the bid. Bid without EMD will not be considered.
- f) The successful bidder's bid security will be discharged upon furnishing the performance security.
- g) Performance Security: The selected bidder shall furnish performance security to NEDFi in the form of Bank Guarantee / FD for an amount equal to 5% of the value of purchase order before releasing of final payment.
- h) The Performance Security will be discharged by NEDFi after a period of 5 years from the date of completion of the work.
- i) The selected bidder must complete the project within 30 days of the date of work order.

- j) Payment: 100% against successful supply, installation & commissioning of the items.
- k) NEDFi reserves the right to cancel/reject/terminate/amend the tender at any stage with/without assigning any reason thereof. Bid submitted after the last date/time of submission, incomplete documents and ineligible bid will be rejected. The decision taken by NEDFi will be final and binding to the bidder.
- l) For any queries, interested parties can contact/email on or before 01-Nov-2024.
- m) If there is any arbitration, the jurisdiction will be at Guwahati only.
- n) Bidder has to submit their technical bid as per the format given in "ANNEXURE-A & ANNEXURE-B".
- o) Quoted products should not be end of life/end of sale/nearing end of life.
- p) Bidder shall have to submit their Financial Bid as per format given in "ANNEXURE-C"
- q) Selection Procedure: All the eligible & technically qualified bidder will be allowed to participate in the "Financial Bidding" and the Bidder with "Lowest Bid Value" will be awarded the Job.
